We recommend an increase specifically to our Cedar/Spruce as these are typically bought only in bundles for landscaping beautification vs. reforestation. Seperating these small orders is time consuming but also still represents a savings to the land owner.

Our Western Larch is being grown seperate from our other species hence the box/wicket count difference.
