Tensed Day's is July 9, 2022, from 10 am to 4 pm. Kylie mentioned her, Katie with ISWCC, and Todd Higens with DEQ visited landowner properties to look at their streambanks along the Hangman Creek Tributary. She mentioned that DEQ is looking into doing a §319 on the Creek Road for Daman Bros. To do this project we will be working with Whitman County. She reported that her, Dave Crabtree, Katie

on board with the work that needs to be done. For the Moses Mountain Road Project 5 culverts will be replaced as well as adding a geo textile to a springy spot in the road. Kylie reported on Davis Weatherlink station and had two models to choose from. The Board will be purchasing the higher end model with NACD grant funds.
